## **NOTICE OF RACE**

### **1. RULES**

*1.1 This regatta will be governed by the 'rules' as defined in The Racing Rules of Sailing; 2013-2016 (RRS).*

*1.2 U.S Sailing Prescriptions to RRS 60, 63.2 AND 63.4 will not apply*

*1.3 VX One 2015 Class Rules, Dated October 1<sup>st</sup>, 2015.*

**2. ELIGIBILITY** – Entrants shall meet all VX ONE requirements including but not limited to: VX ONE class membership.

**3. FEES** - The entry fee is \$ 50.00 per boat. A \$5.00 deduction is allowed to current US SAILING members.

**4. SCHEDULE OF EVENTS** – Seven (7) races are planned. Three races are required to be completed to constitute a series.

### **5. MEASUREMENT, EQUIPMENT CHECKS and CREW WEIGHING –**

*5.1 A boat or equipment may be inspected at any time for compliance with VX ONE Class rules and the sailing instructions.*

*5.2 Skippers and crews will be required to comply with Class Rule C.2.1, a thru e.*
